You can also go online to your county's public health department. Delta Center will provide attendants with a form letter if they need proof of employment as a healthcare personnel.

COVID-19 Vaccine Availability

Phase 1A

- All patient-facing healthcare personnel
- Congregate care facility staff and residents
- EMS and high-risk non-congregate healthcare providers
- Vaccinator staff and those administering COVID testing

Phase 1B

- Tier 1:**
- First responders
 - Emergency services
 - Emergency management and public works
 - Non patient-facing public health personnel
- Tier 2:**
- Anyone age 65 and older
 - Adults 18+ with certain health conditions

- Tier 3:**
- Critical Infrastructure

Phase 2

- Equity and Economic Recovery**
- Chemical Industry
 - Commercial facilities
 - Critical manufacturing

 - Government
 - Higher education

 - Disproportionately affected populations

Phase 3

- All individuals ages 16 (for Pfizer-BioNTech) or 18 (for Moderna) and older who remain unvaccinated.

Note: All examples provided are not exhaustive. Moreover, they are not mentioned explicitly in the order they will receive the vaccine. Vaccine administration within these prioritized populations will take into account numerous variables. The vaccination process will be as transparent as possible and directly involve the populations listed.

Kick off 2021 on the right path. Let's discuss the recent important changes made to payroll.

Q: When is the best time to submit an edit slip?

A: Immediately. It's best to submit an edit slip the moment you realize that you didn't clock in or out.

Q: What's the deadline for submitting edit slips?

A: Within **5 five** business days.

Q: What is the consequence for not submitting an edit slip on time?

A: Your attendant will not be paid for the date(s) edit slips were needed on that paycheck. Once received, the attendant will be paid for those dates on the next pay date.

Q: What happens if there is a power outage, not allowing my attendant to clock in or out?

A: Contact your ILS within 24 hours and submit an edit slip.

Q: What happens if my attendant forgot to clock in **AND** out?

A: **ONE 1** edit slip will be accepted during your time with Delta Center for forgetting both. It's important that you manage your attendant's time.

Delta Center awarded United Way Grant
